Board Initiatives



During FY 2024, the Four County ADAMhs
Board underwent several personnel changes. When
Diane Goings announced her retirement plan, Angie
Abels was hired to replace her as the new Director
of Finance and Administration. Rob Giesige retired
at the end of 2023, at which time I was promoted
and became the new CEO. After faithfully serving
as our Manager of Community Services for the past
5 years, I promoted Bethany Shirkey to Director of
Quality Improvement, and hired BJ Horner as the
new Manager of Community Services. I am excited
about our team and looking forward to all that we
can do together to serve our communities.

The Board invested in several Capital Improvement Projects, and one of those projects has completed construction. Serenity Springs is a women's sober recovery home located outside of Wauseon. Residents will be able to live in a safe, monitored home environment while they continue to build on their skills to support their own recovery. They will also have the opportunity to strengthen their recovery support systems with family visits and parenting time. An Open House was held on May 31, 2024, and in June they had their first residents.

Another project the ADAMhs Board has partnered with is A New Home Development's Upton II housing. Upton Heights was the first housing development of its kind in Defiance County to offer supportive, monitored housing services for individuals recovering from co-occurring mental health and substance abuse diagnoses who are at risk for homelessness. The expansion, Upton II, will be adjacent to Upton Heights, and will create 10 additional apartments. A ground-breaking ceremony is anticipated in mid-fiscal year 2025.

I am proud of the accomplishments of FY 2024 and I look forward to continued growth and improvement in our local system of care as we enter into FY 2025. Thank you for your confidence in me and my team.
